What is the purpose of this update?

This document tells you how the Automatic Fund (Age 80) has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Automatic Fund is a life cycle investment option. Its objective is to achieve the optimum long term outcome by accepting a higher investment risk and return volatility in the early stages of a member's working life as a trade-off for potentially higher returns.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the

fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor
