Fund Update for the year ended 31 March 2022

This fund update was first made publicly available on 1 July 2022.

What is the purpose of this update?

This document tells you how the Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Balanced Fund target asset allocations are 50% in growth assets and 50% in income assets. Its objective is to reduce the likelihood of negative returns over the short to medium term through higher proportions of investment in defensive assets, such as cash and bonds, while still providing a reasonable opportunity for positive real returns over the longer term by investing a reasonable proportion of the Fund in growth assets such as equities and property.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high).

The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Ian had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Ian received a return after fund charges were deducted of \$94 (that is 0.94% of his initial \$10,000). Ian also paid \$54 in other charges. This gives Ian a total return after tax of \$40 for the year.

Notes

The fees charged include an estimate for in-fund costs which are fees and expenses recovered from the
underlying funds we invest in by the respective fund managers. The in-fund costs are not fixed as the
actual amount of these costs will vary slightly from year to year based on average balances. This means
