## Fund Update for the year ended 31 March 2023

This fund update was first made publicly available on 26 June 2023.

## What is the purpose of this update?

This document tells you how the Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

The Aggressive Fund target asset allocations are 90% in growth assets and 10% in income assets. Its objective is to achieve a high level of real returns over the medium to long term primarily through investment in equities, accepting that the returns may be subject to significant short-term variations.



## How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return since the fund started, up to 31 March 2023. The Market Index Returns do not include any tax, expenses or charges.

Small differences in fees and charges can have a big impact on your investment over the long term.


lan had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year lan received a return after fund charges were deducted of -\$181 (that is -1.81% of his initial \$10,000). Ian also paid \$54 in other charges. This gives lan a total return after tax of -\$235 for the year.

#### Notes

1. The fees charged include an estimate for in-fund costs which are fees and expenses recovered from the underlying funds we invest in by the respective fund managers. The in-fund costs are not fixed as the actual amount of these costs will vary slightly from year to year based on average balances. This means that this component of the annual fund charges can only be estimated.
